Institution has an IT policy covering wi-fi, cyber security, etc., and allocated budget for updating its IT facilities.

Our College has an IT policy covering all major areas like wi-fi, cyber security etc. which is amended and updated whenever required as per the need of our College. The IT infrastructure is upgraded periodically, such as augmenting new desktop systems, wi-fi facility to staff and students, Enterprise Resource Planning (ERP) system, software upgradation, ICT enabled teaching, learning facility, cyber security, CCTV facility etc.

The acceptable use policies are applicable to Teaching Staff, Non-Teaching Staff, Students, Vendors and Visitors. Our College Website hosting and Database Usage Policy through ERP system have their own hierarchy which is followed systematically. All the administrative and academic activities like Financial Management, Admission Process, Examination Process, Attendance System, conduct of Online classes, Payment of Fees by the students etc. are governed by ERP System. The violation of IT policy by anyone will have to face the disciplinary action taken by our College authorities.

Our College allocates 4% to 6% of the annual budget for upgradation of IT infrastructure which is audited as per the balance sheet and changes in the system as follows:

1. Our College campus is enabled with 200 Mbps (1:1) BSNL Internet Leased Line facility and 200 Mbps (1:1) Airtel dedicated Leased Line facility. The total bandwidth of Internet facility is 400 Mbps.
2. Wi-Fi network facility have been deployed across the campus and hostels. Students and faculty members are able to access internets to carry out their academic activities.
3. Our College has high end Fortinet Fortigate 600E Firewall with all licensing features which increased cyber security.
4. Our College has over 1500 desktop systems with i3 / i5 processor, 4 / 8 GB RAM and 1 TB Hard Disk for better performance. We have also upgraded our Servers with 64 GB / 100 GB RAM and 5 TB Hard Disk.
5. Attendance for staff is recorded through biometric (Face detection/Finger print) system.
6. CCTV cameras have been installed across our College Campus and also in Men and Women hostels for providing better security.
7. Our College has an Audio Visual Studio with latest technology multimedia device, that is Apple Mac PC, Sound Mixer, Video Cameras and Projectors.
8. Our College as Microsoft Campus Agreement, entitled to use Microsoft Software with all licensing features by the students and staff members.
