In Disability and Social work Paper rights of persons with disabilities Act 2016, 2017 need to be included

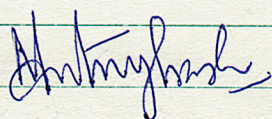
In medical Social work Paper Health Policy 2017 NHTM and Transplantation of Human Organs Act need to be included.

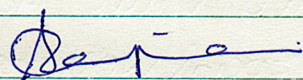
In Mental Health Paper New Mental Health Act 2017 needs to be included. Structure and functions of Brain needs to be added in the Ist unit.
